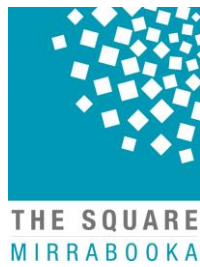


DINE WITH US - TERMS AND CONDITIONS
